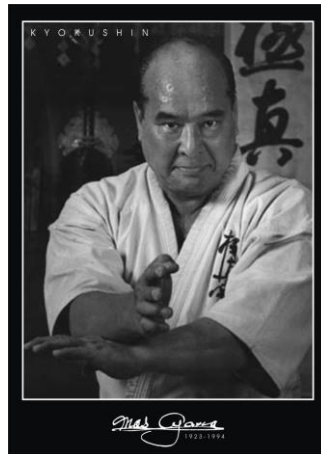

- Cadet (boys and girls) 2003-2004 – EKO cadet rules
- Junior (boys and girls) 2001-2002 – Full kontakt (EKO junior rules)
- U21(boys and girls) 1998/99/2000 – Full kontakt (EKO U21 rules)
- Adults C. (boys and girls) 2000 and old – Full kontakt (EKO junior rules)
- Adults B. (boys and girls) 2000 and old – Full kontakt (EKO adults rules)

Combat times:

- Children I, II: 1,5 + 1 minute (weight difference) +1 minute
- Pubescent: 1,5+1,5 +1 minute
- Cadet: 1,5+1,5 +1,5 minute
- Junior 2+2 (weight difference) +2 minute
- **U21:** 3+2 (weight difference) +2 minute
- Adults C. 2+1 (weight difference) +1 minute
- Adults B. 2+2 (weight difference) +2 minute - Anyone who has been on the podium in the National Championships of the last two years can not start in **Adult B**

Weight groups: Note: depending on the number of contestants per category, we split to thirds or quarters. Its a practicing competition!

We kindly ask everyone for cooperation. As there will be no health checkup and weight control prior the competition, please fill in correct weight in the application. Every coach is responsible for the health of his or her cadets, which he or she certifies by signing the corresponding document. Every club leader can request weight control and results review of contestants. Weight can differ by 5% (including gi) from what is stated in the application. **If weight surplus is more than 5%, the club pays a penalty of 30EUR, and the club wont be invited to the next years tournament.** This rule applies for every participant of the tournament. Coaches must announce any absent contestants during registration.

Entry fees: 15 EUR/ person

We are looking forward to see you and hope you will enjoy a good tournament and also your stay in Slovakia.

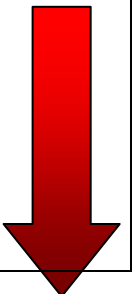
